Mayor Nellist opened the meeting by administering the pledge of allegiance at 7:00pm.

Mayor Nellist began the meeting by discussing several things that transpired over the weekend. Police interviews were held on Saturday, February 2, 2019 for a part time police officer with Chief Braughler, Mayor Nellist, Deputy Mayor Kerth and Trustee Baker. It will be put on Monday's agenda to appoint the officer chosen. Yesterday, DPW Superintendent Mark Remington put up the signage that NC Sign shop made for us to help people locate the new Village Hall and Police Department. One was placed at the fire scene, the next at the end of Main Street with an arrow pointing right, at the end of the drive way to the Village Hall & Police Department and also on the building. They show up nice at night and look great.

Monday, February 4, 2019 at 11:00am a meeting took place at the fire scene with both insurance cause and origin investigators, Mayor Nellist, Mark Remington, Amanda Detschner, Lisa Thompson and Seanna Corwin-Bradley. We were able to answer all questions they asked and they also took pictures and looked at the debris.

Trustee Baker stated that he had begun repairs in the bathroom, but a new sink is needed because the faucet that is broken has to be cut off and it will damage the sink badly. The consensus was that it's ok to purchase a new sink and replace the very old one.

Election petitions are due today through February 13, 2019 by 5:00pm.

On Friday, February 1, 2019 a fundraiser was held at Becker Brewing to raise money for the Barker Library. It was very well attended and all those who attended had a great time. Many of our residents were there, Assemblyman Norris, Mayor Nellist, Clerk-Treasurer Amanda Detschner, Lisa Thompson, Seanna Corwin-Bradley, Library Trustees and various Town of Somerset officials.

Also on Friday, village resident Mike Dietz asked if he could get some of the wood from the Village Hall scene to make a table for the new Village Hall. Once the scene has been released I will let him know that he may take the wood he needs.

Saturday, February 2, 2019 the Barker Fire Department held their annual installation dinner. Clerk-Treasurer Amanda Detschner attended because Mayor Nellist had a funeral to attend. It was Bruce Devereaux's 50th anniversary at the BFD and he was presented with accommodations and proclamations from many political figures.

Mayor Nellist reminded Mark Remington the Code Enforcement Officer that his state report is due April 1st, 2019. He also stated that Terracon offered geotechnical services for our new Village Hall, if needed.

Deputy Mayor Kerth stated that the Clerk-Treasurer will probably be asked to speak at NYCOM or perhaps some other organization because of how much she has learned during this process. She stated she would be happy to do that, if we can help one municipality forgo lessons we have learned the hard way, it's completely worth it.

Trustee Corwin-Bradley stated she received an email from the James's at 8715 Main Street. It stated that his several visits to the Village Hall, his attendance at the Village Board meeting he still feels like he hasn't been acknowledged. We have made our insurance company fully aware of the situation the first day he reported it. Mayor Nellist will call and/or stop by to speak with them about their concern.
