A discussion on Barton & Loguidice Draft Municipal Building Facility Replacement Concept Plan Memorandum and the cost analysis ensued by all members of the Board of Trustees. Mayor Nellist stated that as the floor plan stands right now the Village Hall portion is approx 66% including the basement and the Library portion is approx 33%. He suggested that a joint meeting be held with the Library to discuss these figures and come up with a funding plan. Trustee Seward stated based on how much the Library contributes the Village could renegotiate the lease terms or enter into a co-ownership with the Library. Trustee Davis, Trustee Baker and Deputy Mayor Corwin-Bradley was in agreement and that was a fair percentage based on the information provided by Barton & Loguidice. Deputy Mayor Corwin-Bradley will set up a meeting with the Library Board so this can be discussed further. After the two parties come to an agreement, another joint meeting with Barton & Loguidice, Village of Barker and Barker Library will be scheduled.

A brief discussion regarding the raising of water rates for the 3rd QTR 2020 (July-September) ensued. A resolution to increase the water rates will be placed on the July 13, 2020 agenda and is necessary based on the FY 2019-2020 final balances.
