Resolution #19-2017 Proclamation Commemorating the 200<sup>th</sup> Anniversary of the Town of Amherst, New York WHEREAS, the Town of Amherst, New York celebrates its Bicentennial in the year 2018 and it is fitting to recognize the Town of Amherst on the occasion of this special milestone and to applaud its distinguished history; and

WHEREAS, the Town of Amherst was officially created on April 10, 1819 from part of the Town of Buffalo (later known as the City of Buffalo), has a total area of 53.28 square miles, is the largest Town in Erie County, New York and includes the Village of Williamsville, as well as the hamlets of Eggertsville, Getzville, Snyder, Swormville and East Amherst; and

WHEREAS, In the nineteenth century Amherst was a prosperous farming community with seven grist mills, several saw mills, a tannery and boot and shoe factory and two forges with commercial activity centered in Williamsville; and

WHEREAS, the Town grew from being primarily a farming community to an urban community in the twentieth century with the creation of new subdivisions, the building of the University of Buffalo Campus in Amherst and the location of the Millard Fillmore Suburban Hospital within the Town; and

WHEREAS, the Town body is comprised of 125,000 residents and provides many facilities and attractions including: a four rink recreational facility that attracts national and international ice tournaments, a state of the art senior center, three libraries, and a State Park; and

WHEREAS, The Town of Amherst will proudly mark its 200<sup>th</sup> Anniversary with a series of celebrations throughout its Bicentennial Year, beginning on January 1, 2018 with a 200<sup>th</sup> Birthday Party and continuing with a gigantic Parade, historic walking tours, slogan contest, Interclub Service Club Luncheon and a gala Bicentennial Ball; and

WHEREAS, In recognition of the Town of Amherst's rich history and enduring contributions, it is indeed an honor to pay tribute to this Town upon the occasion of its Bicentennial;

NOW THEREFORE BE IT RESOLVED, That Congratulations are sent to the Town of Amherst on their Bicentennial and the Town and its residents are to be enthusiastically recognized as they celebrate this auspicious occasion; and

BE IT FURTHER RESOLVED, that a copy of this Resolution, suitably engrossed, be transmitted to the Town of Amherst Bicentennial Commission.

Mayor Nellist gave some background about the project because it's something that he tried to get started in 2012, the initial meeting had a great turn out by various community organizations, but then when it came time to have a lead agency designated to spearhead the project no one stepped up. Therefore the project was put on hold. Trustee Corwin-Bradley offered to help Chief Braughler will this project.

# Public Comment was offered by:

<u>Dale Howard:</u> Spoke about the basketball court/ice rink and stated he thinks it's a great idea. He also stated how our parks are kept impeccable and how gorgeous they look because of the attention to detail. Since he lives next to the Lake Park he commented on how much less litter there was this summer. Mayor Nellist thanked Mark Remington and his crew.

#### **Board Comment** was offered by:

<u>Mayor Nellist:</u> Stated that a homeowner who has raised issue in the past with the drainage in front and behind his property on Main Street will be sent a letter in the week to come. He stated that drainage for the entire Village is a priority but comes with a hefty price tag; therefore it's not just one homeowner who has these issues. As well as stating the reason for updating the Capital Improvement Plan.

<u>Deputy Mayor Kerth</u>: Inquired about the County fixing the area that was paved in 2016 where water stands by the Post Office on Main Street. It was explained that the issue is a drainage issue not a road issue.

<u>Trustee Corwin-Bradley</u>: Gave an update on the child safety seat check facilitated by the Niagara County Sheriff's Department Traffic Safety Coordinator. A tentative date of March 24<sup>th</sup> is set, most likely from 10:00am until 1:00pm. If the weather was still iffy the Barker Fire Department would allow the use of their facility, as per Seanna's conversations with the President and Fire Chief. Office Braughler would like to have a Village PD presence, as well. The traffic safety coordinator will pass out literature to the school students and advertise the event.

A motion for **Adjournment was made at 7:38pm** by Trustee Corwin-Bradley and was seconded by Deputy Mayor Kerth.
