At **7:00pm meeting was called to order** by Deputy Mayor Corwin-Bradley by administering the Pledge of Allegiance.

The Sales tax received for November 2021 was \$11,831.78 an increase of \$1,427.84 from November 2020, but an overall increase in sales tax received since 2020 in the amount of \$16,157.36.

Resolution #43-2021

RESOLUTION OF THE VILLAGE OF BARKER ABOLISHING REGISTRATION DAY FOR VILLAGE ELECTIONS

WHERAS, The Village of Barker passed a resolution abolishing voter registration day for the Village Election several decades ago; and

WHERAS, the Village of Barker suffered the loss of some permanent records from the January 20, 2019, fire that burnt the Village Hall and Barker Library building to the ground that contained such record of abolishment; and

WHEREAS, the Village Board of the Village of Barker, after due consideration hereon, has determined that a separate registration day for electors within the village is not warranted;

NOW, THEREFORE, LET IT BE HEREBY

RESOLVED, by the Village Board of the Village of Barker that, pursuant to New York State Election Law Section 15-118(3), there shall not be any village registration day for village elections.

WHEREAS, the Village advertised a project for public works, PRC # 2021008825, for the construction of the Village of Barker Village Municipal Building Foundation, and such bids were received and publicly opened at 1697 East Avenue, Barker, New York on November 2, 2021, at 2:00 p.m., now therefore be it

RESOLVED, that the Village of Barker hereby rejects all bids for PRC # 2021008825 and directs the Village Clerk-Treasurer to notify all bidders.

Resolution #45-2021

AUTHORIZIATION TO ADVERTISE BIDS FOR VILLAGE HALL/LIBRARY MUNICIPAL BUILDING

WHEREAS, the Village of Barker intends to construct a Village Hall building, that has been redesigned to accommodate metal construction; and

WHEREAS, a designated portion of the building will house the Village Hall, a meeting room, shared bathrooms, and the Barker Public Library; and

THEREFORE, BE IT RESOLVED, that the Village Board of Trustees authorizes the bidding of the Village Hall and Library municipal building upon completion of the engineering design plans.

A motion to ADOPT Resolution #45-2021 was made by Trustee Davis and a second was offered by Trustee Hirschman.

The previous was ADOPTED. AYES – 4 – Corwin-Bradley, Davis, Gow, Hirschman NAYS – 0/None ABSENT-1-Nellist Motion Carried.

The NYPA LED Streetlight Project Update was proved by Trustee Davis. He stated the 90% plans have been signed off on and we are awaiting the 100% plan. If the 100% plan is the same as NYPA projected, we will move forward with the final agreement. He also stated they said it is approximately an 8 week lead time before the fixtures will be delivered from the order date.

A motion to approve the NYPA Customer Project Commitment Contract (CPC) and 100% design, as long the project scope was unchanged from the 90% design was made by Trustee Hirschman and a second was offered by Trustee Gow.

The previous was ADOPTED. AYES – 4 – Corwin-Bradley, Davis, Gow, Hirschman NAYS – 0/None ABSENT-1-Nellist Motion Carried.

Proposed changes to the Chicken Ordinance of the Village Code was brought up for discussion by Trustee Davis. Davis mentioned as of now Village residents are not permitted to have chickens on their properties. Trustee Davis and Deputy Mayor Corwin-Bradley have both been approached by residents requesting the board to allow residents to own chickens. Trustee Davis provided a draft proposal for Hen Chicken yearly Permits and proposed updated code.

Trustee Davis proposes that residents will have to submit a permit application to the board at a public monthly meeting. He also proposed that the resident may own only 6 hen chickens, no roosters, a maximum sized coop and run, a minimum distance the chicken must be from any dwelling, that the chickens may not free range and that the sale of eggs or chickens would not be permitted.

Trustee Hirschman inquired as to why residents would not be allowed to sell eggs at the road. Davis explained that with only being allowed 6 hens that a resident would not have enough to sell.

The board discussed that the proposed setbacks would limit who could have chickens.

Neal Gordon asked the board where the line would be drawn. Chickens, ducks, geese, and turkeys are all poultry.

Trustee Hirschman stated that the coops and runs would have to be inspected by the Code Enforcement Officer The board has tabled this discussion until next month.

The Clerk-Treasurer's Financial Reports were reviewed and accepted by the Board of Trustees.
